

BUSINESS TRUST AGREEMENT

This Agreement, made this 8th day of January 2018, between Recreate.inc (hereinafter called "ABC") and _____ (hereinafter called "XYZ") ,
Witnesseth That :

Article1. Appointment

ABC shall hereby appoints XYZ as its trustee who transacts ABC's business in Web section for or on behalf of ABC and XYZ agrees and assumes such appointment.

Article2. Scope of Business Services

ABC may entrust certain part of its business to XYZ from time to time. The scope of the business which ABC entrusts to XYZ shall be as follows :

- a) project, create, operation, management of Web site ABC accepted.
- b) Other matters otherwise entrusted by ABC.

Article3. Trust Procedure

1 . During the life of the Agreement, ABC shall, in sending message by IT tool(Trello, facebook, Skype) or orally, offer the trust of the business as provided in the foregoing Article.

2 . In case that XYZ can not accept for such offer by just cause, XYZ shall give ABC a written notice stating the causes by using IT tools as soon as possible.

3 . Business services by XYZ hereunder except those expressed herein shall be defined by ABC after negotiation with XYZ from time to time.

Article4. Best Effort

XYZ shall exert its best effort to carry out the business services entrusted hereunder by ABC.

Article5. Performance of the Service

XYZ shall sincerely comply with " LABOR REGULATIONS FOR PHILIPPINES " ABC established(hereinafter called " REGULATIONS").

Article6. Payment

ABC shall, as to XYZ's services in this Agreement, pay to XYZ the wage.
The Amount of money and how to pay are decided by REGULATIONS.

Article7. Secrecy

During the life of this Agreement and thereafter, XYZ shall not divulge any confidential information which it may acquire in connection with this Agreement or performance thereunder.

Article8. Duration

This Agreement shall commence as of the date first above written and have the term of one month. The extension of the term of this Agreement shall be determined under the discussion between the parties hereto before the expiration of this Agreement.

Article9. Cancellation and Termination

1 . In case that either party commits a breach of contract and such breach is not cured by the party after sent notice complaining of such breach is given by the other party, the other party may terminate this Agreement.

2 . After this Agreement is terminated, XYZ shall do, As instructed by ABC, return and send to ABC data, documents and items in connection with this Agreement.

Article10. Damanges

XYZ shall be responsible for any losses or damage incurred if either should violate this Agreement and REGULATION.

Article11. Assignment

The rights and obligations of this Agreement are personal to the parties hereto and shall not be assigned without the prior written consent of the other party.

Article12. Consultation

Any matter not stipulated in this Agreement or any doubt arising with respect to any provision of this Agreement shall be resolved upon mutual consultation between ABC and XYZ.

Article13. Language

This Agreement has been executed in two copies with equal force and effect in English language. No translation into other language shall be taken into consideration in the interpretation of this Agreement.
